Foreword

2015 was an exciting year for Limerick Youth Service. After a protracted period of identifying a suitable project, site and securing planning permission, the construction of the Northside Youth Space began, with the project creating huge expectation and excitement amongst young people, volunteers and staff.

Youth Work continued to develop with the advent of new integrated hubs across Limerick and a refocusing of energies in work with new communities, minority and special interest groups and migrants.

Summer programmes in particular outreached to more areas and saw the skills and talents of young people and junior leaders come to the fore. For the first time, young leaders from the Community Training Centre worked with youth workers in assisting the facilitation of a range of programmes and activities. International Youth Work continued to be a priority and volunteers from West Limerick joined their City counterparts and staff in both travelling and hosting groups.

Work on Governance and registration with the Charities Regulatory Authority as well as conversion of Audited Accounts to SORP format, compliance with FRS102 and compliance with DPER requirements were priorities for the Board and Management.

Limerick Youth Service continued to engage with the National Quality Standards Framework (NQSF) and rolled out the National Quality Standard for youth clubs and groups during 2015.

Over 4,000 young people across Limerick participated in youth projects, clubs, cafés and programmes, while 160 learners engaged in second chance education and further training programmes at the Community Training Centre and Local Training Initiative.

Following six years at the helm, the Board acknowledged the sterling leadership of Mary English in her term where the Organisation sustained significant funding and other challenges. Patrick Lynch took office as Chairman at the Board AGM in December 2015 and we wish him every success.

Sincere thanks to all those who keep Limerick Youth Service robust, vibrant and relevant to young people – the Board, volunteers, stakeholders, funders and staff engaged throughout Limerick.

Limerick Youth Service: Structure & Governance

Structure

Limerick Youth Service is registered as a Scheme of Incorporation by the Commissioners of Charitable Donations & Bequests in Ireland, under Section 2 of the Charities Act 1973. The Scheme and Constitution were revised in 2011 and approved and sealed by the Commissioners for Charitable donations and Bequests for Ireland in December 2011.

Employing 100 staff, Limerick Youth Service has 500 volunteers engaged in various aspects of its work with 10–25 year olds throughout Limerick City and County (population 191,809).

Limerick Youth Service is an integrated youth service and one of 22 member organisations of Youth Work Ireland.

Board Membership and Officers

Limerick Youth Service is governed by a voluntary Board which is responsible for the overall governance of the Organisation. The day to day Management of Limerick Youth Service is devolved by the Board to the CEO and Senior Management Team.

Limerick Youth Service is under the patronage of the Roman Catholic Bishop of Limerick and the Church of Ireland Bishop of Limerick and Killaloe, each Bishop nominates two representatives to the Board. At least four Board members shall be actively engaged in organisations relevant to the workings of Limerick Youth Service, but must not act as a representative of that group in acting as a Board Member. Vacancies are filled based on skill deficit as per annual Board skills audit document. Board members having served a three year term at the time of the AGM shall retire and may be eligible for re-election for one further three year term.

Youth Development

From volunteer led youth clubs and junior leadership programmes to international youth exchanges and youth engagement, LYS projects complement the development of a young person.



International Youth Work

Over 40 young people from Limerick experienced the culture of Malta as they participated in youth exchanges with the youth organisation ZAK Malta, while one person volunteered in Finland as part of the European Voluntary Service (EVS) Programme.

As part of the youth exchanges, titled Extend-YURT & The Shift, young people tackled the issues of youth (un)employment and mobility while the bilateral programmes also allowed young people to experience new cultures with Maltese youths spending time in Limerick.

Comhairle na nÓg

40 teenagers from across Limerick City & County continued to be a voice for young people as members of Limerick Comhairle na nÓg. Led by young people, this Youth Council addressed the impact on homelessness and living in Direct Provision on the mental wellbeing of young people.

Comhairle na nÓg also hosted Let's Go Mental with over 100 teenagers attending the event in UL which illustrated the importance of positive vouth mental health.









Youth Cafés

Youth cafés continued to remain popular spaces for older teenagers and in 2015 LYS continued to deliver youth cafes at three locations in Limerick City: Lava Javas in the city centre, the Laff Caff in The Factory, Southside Youth Space and Northside Youth Cafés.

Youth Cafes create a safe, social spaces for young people, where they have the opportunity to take part cultural, music, street art and mental health initiatives to name but a few!

Youth Clubs

Up to 1500 young people continued to access weekly volunteer led youth clubs where they spent time with friends and took part in social and personal development programmes.

Youth club members also participated in annual events such as Youth Work Ireland's Youth Factor Variety Show and Youth Games.

Each youth club is supported by a nominated LYS Club Support Worker whose role is to develop the club, train volunteers, support club and programme development and facilitate networking across clubs.

These youth clubs continued to be a much needed and welcome social outlet for young people.

Special Projects for Youths

LYS's Special Projects for Youth (SPY) continued to support young people in the delivery of after school and holiday provision across LYS's youth spaces and via our outreach services. With these projects young people took part in a diverse range of programmes such as animal welfare, healthy eating, creative arts, leadership skills and had fun!

LYS's SPY projects were also to the fore in delivering events such as games, discos, youth factor, interclub activities and more!

Youth Support

Youth & Family Support Project

Supported by Tusla, the Child & Family Support Agency, LYS's Youth & Family Support Project worked with 170 young people aged 10-16 in facing life challenges and progressing to new opportunities.

Through group work or 'one-to-one,' LYS staff provided specific supports and interventions to young people and were active in the Meitheal National Practice Model.

Working with children and families, the Meitheal Model enables the needs and strengths of children and their families to be properly identified, understood and responded on an interagency basis.

Garda Youth Diversion Projects

Run in partnership with An Garda Síochána, Limerick Youth Service has 3 Garda Youth Diversion Projects with 7 youth justice workers operating in some of the most marginalised communities in Limerick City and County.

LYS's youth justice workers engage directly with targeted project participants in a youth work process of personal and social development that relates to offending behaviour, substance misuse and/or antisocial behaviour.

LYS's projects in King's Island, Ballynanty, Irishtown and Henry Street Outreach, worked with 77 referrals and supported young people in a range of individual and small group interventions on issues such as behaviour management, personal and social development and making positive life choices.



Brian, Irishtown Garda Youth Diversion Project

At 16 I joined Youthreach to sit my Junior Cert and what followed was a journey with LYS where I am now a sessional youth justice worker with Irishtown Garda Youth Diversion Project.

As a student with Youthreach (which was based in LYS), I got involved in youth work participating in a junior leadership training programme and becoming a volunteer with St. John's Youth Club.

With a growing love of youth work, I was part of the team that developed Lava Javas and the Laff Caff youth cafés.

With LYS, I have led youth exchanges to England, France and Italy, adventures I really enjoyed.

I am currently studying a Diploma in Youth & Community Work at Limerick College of Further Education and would like to pursue a fulltime career in youth work, particularly in the Garda Youth Diversion Project sector.









Signposting for Youth

LYS's counselling initiative, Signposting for Youth, worked to capacity in 2015 and supported 64 young people aged 14 to 24 in the provision of direct counselling support.

Significant progress was made in the area of mental wellbeing with the recruitment of a Youth Mental Health intern.

Youth Information & Communications

In this ever changing 'Information Age,' LYS continued to provide comprehensive and easy access to information for young people and adults.

Youth Information was active in advocating for & raising awareness of youth issues and supporting young people in making positive life choices.

From youth voter registration and career guidance to tips on gaining employment and working with minority groups, Youth Information was to the fore in youth issues.

In the media world, Youth Information continued to portray the positive contribution of young people in the print and social media and promote the importance of youth work and second chance education opportunities.











EDUCATION E TRAING

LYS continued to provide second chance and further education programmes for early school leavers through a variety of programmes at our Community Training Centre and at the Local Training Initiative, located at Nicholas St, Limerick.

Community Training Centre

177 young people were enrolled in a number of diverse and innovative programmes that provided education and training opportunities to those (15-21yrs) who, for a number of reasons had left school early. The programmes available were:

- Level 3 Employability Skills
- Level 4 Pathway to Employment, Childcare Skills, Office Studies, Hospitality & Tourism
- Level 5 Business Studies & Retail Sales
- Leaving Cert Applied
- Diploma in Proficiency in Baking Industry Skills
- Youth Advocacy

The above training programmes not only focused on learner's education and training but on their well-being and personal development, with many young people participating in youth work activities such as junior leader training and international youth exchanges.

Many of the young people have progressed to further education courses, such as Limerick College of Further Education, while more entered employment.





Abbey Youth Local Training Initiative

As it entered its fifth year 13 young people, primarily from the King's Island and Lee Estate communities of Limerick City, were enrolled with Abbey Youth LTI.

The training initiative is designed to provide opportunities for marginalised learners who have left school early and, for personal, social or geographic reasons, are unable to participate in other training interventions. Abbey Youth provided vocational training opportunities, learning supports and project-based learning to assist participants achieve awards on the NFQ (National Framework of Qualifications) and to develop the capacity to progress to further training, education and work.

Abbey Youth: A tale of two sisters

Leanne joined the Abbey Youth LTI Programme in September 2013 and quickly became an integral part of the programme where she focused on pursuing a career within the Health & Beauty Sector.

After completing her QQI Level 3 Employability Skills Award, which included a work placement with a leading hair salon, Leanne was offered an internship and after successfully completing this, became a valued team member.

The following September Leanne's sister joined the LTI programme with a view to working within the Hospitality sector. Upon successful completion of the programme she progressed to the Hospitality Education & Training Centre in Roxboro where she completed a Food, Beverage and Culinary Skills programme. She is now a barista and managing an upmarket coffee shop in a major European city.
